AUDIT FINDINGS

Narrative:

The Prison Rape Elimination Act (PREA) Audit of the Lancaster County Youth Intervention Center was conducted on October 21, 22, 2019 by Maureen G. Raquet, Raquet Justice Consultants LLC, a Department of Justice Certified PREA Auditor for Juvenile Facilities. This is a re-audit of the facility conducted during the first year of the third PREA cycle. This facility was initially audited during the first PREA cycle in October of 2014 and was found to be in full compliance on November 26, 2014. The facility was re-audited, on October 24, 25, 2016, during the first year of the second PREA three year cycle and was found to be fully compliant in January 17, 2017. Notice of this Audit was posted on September 9, 2019 , and I received an email with pictures of the posting in the living units and public areas on this date. The facility was requested to keep these notices posted during this six week period and they were still posted in all areas during the tour on October 21, 2019. There have been no communications received as a result of this posting in the Auditor's Post Office box. On Sept. 18, 2019, I received notification of an on-line Pre-Audit Questionnaire being completed. During this period, through emails and phone calls with the PREA Manager/Facility Director additional information was requested and uploaded. The agenda for the onsite portion of the Audit was emailed to the PREA Manager on October 7, 2019.

The onsite portion of the Audit commenced with a brief entrance interview with the Facility Director/PREA Manager, Shelter Director, PULSE Director, Business Administrator, Program Coordinator, Adolescent Therapist and a Nurse. At this time, I was provided with a census of all residents in the facility and a staff schedule for the week. This was followed by a tour of all areas of the facility that the children have access to.

During the tour, I saw postings for the upcoming Audit in the front lobby area, in every living unit and every common area that the residents have access to. In addition there were posters in both Spanish and English in all areas, including the visiting area describing PREA, describing Sexual Abuse, providing reporting information for the Lancaster County YWCA and providing constant reminders to both staff and residents about boundary issues and "drawing the line".

Upon entering the front door of the reception area there are PREA pamphlets next to the visitor's log with information for parents, visitors, volunteers and contractors. A notice of the upcoming Audit was affixed to the counter next to the Visitor sign in book. There was a PREA reporting box on the wall in the lobby. While on the tour, I saw the "Gray Phone" that is located in the hearing room and that is a hotline to the Lancaster County YWCA. There are posted directions for its use. The YWCA is a member of the Pennsylvania Coalition Against Rape. I followed the posted directions and I reached the emergency reporting line for this agency. During the pre-Audit time period, I contacted the YWCA Director, who confirmed both the reporting capability and all other services in the MOU provided to me, including crisis intervention and providing a victim advocate for the residents. The YWCA Director also stated she was not aware of any incidents or problems at the Youth Center. A female Shelter resident volunteered to show me how to report by using the confidential PREA dropbox or the hotline.

During the tour, I also spoke to a maintenance employee, a teacher's aide, and a dietary employee who told me that they had received PREA training each year and as recently as one month ago. One dietary

contracted employee stated that she had started work at LCYIC just three weeks ago and had not received her PREA training yet. Prior to the end of the onsite, documentation of her PREA training was provided to me. I spoke to Detention and Shelter staff who received training and they told me that Administration conducts unannounced rounds on a regular basis. While onsite, I viewed a video recording of a random unannounced round that was conducted on a third shift, by an Administrator. Recording capability is for approximately 30 days. However, the Facility Director "burns" a copy of the round when he receives documentation that an UAR has been conducted.

During the tour, the on-duty Nurse could tell me what training she had received and showed me where a resident could be seen privately in the Medical Suite. She showed me where the health records are privately kept electronically on her computer in her locked office in the Medical Suite.

During the tour, all residents were in school, except for two boys on Unit confinement in Detention. I had the opportunity to see the residents supervised in group settings in the classrooms and also during a lunch period. They attend school and eat by living unit, so that the group never exceeds twelve. On the living unit I observed two boys and two staff. In the library I observed three Shelter girls with 3 staff. There was only one girl in Detention and one female staff is always assigned to her. I observed 10 Detention boys in a classroom with a teacher, an aide and two Detention staff. The teacher and aide do not count in ratio. Staffing exceeded both the PREA requirements and that of the Pa. 3800 Child Care regulations.

On the units, I heard "knock and announce" practiced when male staff entered the all female shelter unit and when female staff entered the male unit. There were postings next to each living unit door, directing the opposite gender to announce themselves.

Staff who conducts PREA education at Intake

Shelter Director who is a member of the Sexual Abuse Incident review team and conducts UARs

Program Coordinator who conducts UARs

Four Volunteers (one by telephone)

Four Contracted employees (including the two nurses listed above)

Twelve (12) random staff

Ten (10) random residents

The twelve staff interviews represent 19% of the 62 direct care staff. Staff are both full and part time and work permanent shifts with rotating days off. Males work on male units and females work on female units. In addition to a roster of all staff employed at the facility, I was provided with a work schedule for the week. From this schedule, I randomly selected staff from Shelter and Detention first and second shifts. I requested that two midnight staff be selected to remain for an interview by Facility staff. PULSE staff primarily only work weekends, when the program runs. There are 62 direct care staff, including supervisors, for Detention, Shelter and PULSE. AFSCME represents only the Detention staff at LCYIC. This contract went into effect on January 1, 2019.

I was given a census of all facility residents separated by living unit and by Program. There were 11 residents in Detention: 10 boys and 1 girl. There were 13 residents in Shelter: four girls and nine boys.

One girl was admitted to Shelter during the first day of the Audit, bringing the total population to 14 in Shelter and 25 in the facility. Of the 25 total residents, I interviewed (10) residents from Detention (5) and Shelter (5). That represents 40% of the total population on the days of the Audit. I interviewed 6 boys and four girls from all 5 living units, that were in use. There were no residents who reported a sexual abuse. There were no Transgender or Intersex residents in the population. There were three residents who identified as bisexual and two were interviewed. There were no physically disabled or non-English proficient residents. There were two residents who identified as having an intellectual disability and both were interviewed. There were five residents who had disclosed prior sexual abuse and I interviewed two. Three residents go out of the facility for school every day and were not available for interview and one Shelter girl refused to be interviewed.

I reviewed the files of 8 staff for required documentation, including three hired within the past 12 months and the files of two volunteers and two contracted employees. I reviewed the files of 13 residents, 11 active and 2 discharges. I was provided a census of all admissions from the past 12 months and randomly picked the discharged files from this list. The 11 active files were those of the 10 residents that I interviewed and one additional Shelter file.

Residents have several means to report sexual abuse and sexual harassment. A few were mentioned above, including the "Gray Phone", a hotline to YWCA and the PREA dropboxes. There is also the grievance procedure, family visiting twice a week, phone calls every week, visits by attorneys, probation officers, and caseworkers. Some Shelter residents go out to school in the community every day. Both residents and staff who were interviewed knew that they could report in writing, verbally, anonymously and through third parties. Staff knew and understood their mandated reporter responsibilities.

Pennsylvania Child Line, by phone or computer, is a mandated reporting requirement for staff, but is also a phone resource for residents as well.

There are MOUs with the Lancaster Hospital for Forensic Examinations with SAFE/SANEs and an MOU with the Lancaster County Detectives and the Lancaster City Police who conduct Criminal Investigations. Pa. Child Line also conducts investigations. This information is posted on the facility website.

During the past 12 months there have been no allegations of sexual abuse or sexual harassment. There have been no reports from other facilities of abuse at the Youth Center and the Youth Center has not received any reports of sexual abuse at other facilities.

In summary, after reviewing all pertinent information provided to me prior to and during the onsite portion of the Audit, interviews with staff and residents, and the tour of the facility, it is apparent to this Auditor that the Facility Leadership and the Staff have spent considerable time and resources ensuring that the safety and security of these residents is the utmost priority. The culture of sexual safety and awareness was present during the first Audit, but is now more ingrained in the facility. There is a PREA Coordinator for both the Juvenile Detention Center/Shelter as well as the County Jail, which underwent a PREA Audit in June 2019. The PREA Coordinator is the Lancaster County Solicitor. She has assumed this responsibility when the Asst. Solicitor left the County, but has recently hired a new Asst. Solicitor who will take over the role of PREA Coordinator. There is a PREA Manager, who is the Director of the Facility. He also monitors retaliation in this role and conducts random Unannounced rounds. He along with his management team have developed and implemented policy and procedure to ensure compliance with the PREA Standards. A new addition to the Facility is the Adolescent Therapist who meets with every new admission to the Center as well as offering ongoing counseling if needed and desired.

The staff and residents have demonstrated that they not only received but understand the education and training. All staff interviewed received PREA training either during PREA implementation in 2014 or as part of orientation training when hired. The Adolescent Therapist had the PREA training that all employees receive, but had not had any specialized PREA training beyond her education. Prior to the 45 day Interim report, documentation of her specialized training was submitted to the Auditor.

All residents receive PREA education during the Intake process and then more comprehensive PREA

education, one on one, with the Facility Caseworker. Additionally, once a month, all residents take a PREA quiz.

There is an ongoing relationship and a MOU with the Lancaster County YWCA, a member of the Pennsylvania Coalition Against Rape, that allows for victim advocacy, emotional support and reporting. A Victim Advocate is always provided for a victim of sexual abuse. There is a MOU with Lancaster Hospital for Forensic Medical Examinations for Residents conducted by SAFE/SANEs. There is a MOU with the Lancaster County Detectives to conduct criminal investigation and with the Lancaster City Police Department who would respond to a 911 call. This information is posted on the website.

The Masters' Level Caseworker conducts the Risk Assessment within 72 hours of Intake and again at 6 months for the Detention and Shelter Residents. The PULSE Weekend Program Director conducts the VAs for these admissions on the first weekend they attend. The Caseworker uses information from the Health and Safety Assessment and other sources to make her risk based housing decisions, but she was not using that information to properly score the Vulnerability Assessment Instrument. As part of the plan of correction the Caseworker submitted all VAs from the date of the onsite Audit up until the 45 day Interim report to the Auditor to demonstrate compliance.

The resultant medical follow ups were done in a timely fashion. The nurse keeps digital records of Medical information. All residents receive a physical within 72 hours of admission. They can also see a tele-psychiatrist for medication evaluations or other psychiatric needs. The Adolescent Therapist meets with every new admission between 24-48 hours from Intake and offers her counseling services to them. All staff and resident logs and files reviewed were complete for both education/training, except for the Adolescent Therapist as noted above. The contractors and volunteers also received the required training. All staff files that were reviewed contained PA. child abuse, criminal history and FBI clearances clearances.

At the end of the onsite Audit, an Exit meeting was held with the following: Facility Director/PREA Coordinator, Shelter Director, PULSE Weekend Supervisor, Case Manager, Adolescent Therapist, Facility Trainer, Prime Care Nurse and the Business Administrator, and Program Coordinator. The preliminary findings of the Audit were discussed, including documentation that needed to be submitted for two standards to be in full compliance. This documentation was received prior to the 45 day report, which also serves as the final report.

This facility is fully PREA compliant effective 12-3-19.

AUDIT FINDINGS

Facility Characteristics:

The Lancaster County Youth Intervention Center was built in 2001 and occupied in March of 2002. It is a County run Juvenile Detention Center and Shelter, in the City of Lancaster, Pa. The program consists of a 96 bed center, divided into 5 wings or units. The units each have two 12 bed sections: in Detention, two units of 36 are designated male and one 12 bed unit is female (total 48 beds). Only three units in Detention, were being utilized during the onsite. On the date of the Audit, there were 11 Detention residents: 10 boys and one girl.

During the past year, 2018, there were 219 admissions in Detention: 167 males and 52 females ranging in age from 10-21. Detention is a temporary placement for the protection of the community or to ensure that residents appear for their court dates. Admission to Detention is regulated by the Detention Standards governing the use of Secure Detention in Pennsylvania. Only delinquent or alleged delinquent children may be placed in Detention by Juvenile Probation or by order of the Juvenile Court. The average stay was 16 days.

There is a 24 bed shelter for both delinquent and dependent children. On the date of the Audit, there were 14 Shelter Residents: 9 males and 5 females. The Shelter unit has a boy's section and a girl's section. Shelter is non-secure by Pa. Department of Human Services regulations but meets the criteria for secure by the PREA standards. Some residents can and do attend school in the community. The Shelter program had 123 admissions in the same time period (2018): 72 males and 51 females. Shelter accepts both male and female delinquent and dependent children from both Juvenile Probation and the Office of Children and Youth. Some of these residents are there through no fault of their own and may need temporary living arrangements. Other residents may be truants, ungovernables or runaways and delinquent children who may not meet the criteria for secure detention. The Shelter program is entirely separate from Detention, with its own dining room and classrooms.

The PULSE weekend program, had 34 male admissions in 2018 and 11 female admissions and begins on Friday PM and finishes on Sunday PM. The children are Court Ordered for 5 weekends. PULSE, in the past, has only accepted male delinquents from Juvenile Probation but now accepts dependent males from the Office of Children and Youth as well as female referrals

The Evening reporting center (non-residential) also operates out of the PULSE program space. In 2018, there were 100 admissions to the ERC: 51 males and 49 females. A Unit formerly used for office space for children and youth has been added to the ERC/PULSE program space. One unit is still used as an office area and is completely locked off from the rest of the center, with a separate entry and exit, but would allow for expansion if needed.

The Youth Intervention Center no longer contracts with any other county to provide care for their residents. This change went into effect January 1, 2019.

The facility is run by the Director, Drew Fredericks, and he reports directly to the County Commissioners. It is licensed yearly by the Pa. Department of Human Services under the 3800 Child Care Regulations. There are 86 full time and part time employees, as well as contracted employees in the Medical/Behavioral Health (Prime Care) and Educational Units (Lancaster City Schools). The Food Service (Aramark) and its employees are also contracted. The direct care or line staff are both full and

part time, and work permanent shifts. The units are staffed by both male and female staff. The Youth Intervention Center has extensive community involvement with over 178 volunteers, who do gardening, writing circle, health and wellness and a variety of other programs. All residents attend school and participate in recreation in the gym, courtyard and library.

The one story, 92,324 square foot building was built in 2001 and is on a 9.06 acre campus that is located within the City of Lancaster, Pa. The front door opens to a very large vestibule that is decorated with the residents' art work. This is the entry used by those attending Court in the Hearing Room. This is also the Administrative/Office area with a Training Room for staff and a conference room. The secure area of the building contains the three living units of two twelve beds sections each. They have single rooms, with built in beds, and a long narrow window to the outside. There is also a window in the door. The bedrooms open onto a common area, which houses a counseling/supervisors' office as well as a separate room that was designed for tv viewing but which is no longer used for that purpose. The bathrooms contain three showers with curtains, sinks and toilets. There are seven classrooms, a library, a chapel, as well as a Multi-Purpose Room, and a gymnasium. A courtyard is also available for both Detention and Shelter children with a vegetable garden and outside recreation. The Detention Unit has a Dining Room with attached kitchen, where the different units eat at separate times.

There is a separate medical unit with private areas for examination and an Intake Area with a drive in sally port. There is a control room with video monitors, manned round the clock by security officers. Both exterior and interior doors are buzzed open by security. There is a key override. The original design of the building had a control room in each unit, but they are not in use.

The Shelter Pod is non-secure, meaning that the children cannot be locked in their rooms or onto the unit, and self-contained with a dining room and a separate intake area and separate classrooms. There is both a girls' and boys' residential unit of 12 beds each. They are identical with a staff office, an interview room, and a dining room. The rooms have built in beds, a small narrow window and a door with a window. These rooms open onto a common area. There is a bathroom on each unit with toilets, sinks and three shower stalls with curtains.

An additional Shelter unit is used for the PULSE Weekend Program and has large comfortable furniture, bean bags, and is decorated to allow for group counseling and other group activities. It has the same configuration as both Shelter and Detention, with 12 single rooms with built in beds and a separate shower/bathroom that open onto a communal living space. The residents are court ordered into this program as part of their probationary disposition. This program includes, groups such as goal setting, community service, and there is a family piece as well.

The Evening Reporting Center also uses this program space, but on Monday through Thursdays. Residents are picked up at home or school by program staff and eat a snack and dinner at the center. They do homework, some groups, such as the evidenced based curriculum: Thinking for a Change and Aggression Replacement Therapy and some Family Work. This is a coed diversionary program. The program space has doubled with the utilization of former office space. Shelter residents can and do participate in ERC evening programming, including groups.

The following standards have been exceeded:

Standard #313 Monitoring and Supervision:

Random unannounced rounds are conducted on all three shifts by a shift supervisor. These rounds are required by policy and are documented. Upper level management also conduct rounds on all three shifts on a monthly basis as required by the PREA Zero Tolerance Policy. I interviewed three administrators who conduct these rounds. Documentation of these rounds are submitted to the Director who then copies a video recording of the round as part of the record. The logs and a video recording were reviewed during the onsite portion of the Audit.

Ratio was exceeded in both Shelter and Detention, both on the schedule and as observed during the tour. Pa. DHS requires 1:6, and 1:12 in Detention and 1:8, 1:16 in Shelter. There were no deviations from ratio. In several cases during the two days onsite, I observed a ratio of one on one. Cameras have been added since the last Audit to capture different angles in the program spaces. Cameras are actively monitored in the control room. There is now remote viewing capability by the administrators on their desk top computers.

Standard #333 Resident Education:

All residents receive education immediately at Intake. They initial each important point of the education, along with a staff person, on the PREA checklist, such as how to report, who to report to, and zero tolerance. Within 10 days, but usually 72 hours, more thorough education is conducted, one on one, by the Caseworker and this information is signed off on as well. Once a month on second shift, staff conduct a PREA refresher training that all residents must attend and they subsequently take a test. The residents also receive a brochure at Intake and there are posters throughout the facility. The interviews of the residents corroborate the above information. One resident in Shelter, who had been interviewed,

stated she had received education several times, because of her length of stay. A review of her file showed she had taken and passed the monthly test 15 times.

There are MP3 players for residents who need audio education due to a disability. Spanish and English posters and brochures are available as is a translation service.

Standard #351 Resident Reporting:

Residents can report in writing, verbally, anonymously and through third parties. There is a "hotline" to the Lancaster YWCA, a PCAR, who accepts reports. There are phones on the living units and pencil and paper available as seen on the tour. There is a grievance form and procedure given to each resident. There are PREA boxes and grievance boxes in several areas of the facility that are checked daily by a Caseworker. The residents have private and confidential access to attorneys, parents, guardians, probation officers and children and youth caseworkers through phone calls and visiting. Shelter residents sometimes attend school in the community or can have home visits. Interviews with random residents showed that they were aware of these reporting avenues. Most of them stated they could tell staff or a parent, but all knew of the "hotline" and the PREA boxes. The staff that were interviewed all knew of the various ways both they and the residents could report. The residents are advised of these avenues at Intake and again during their monthly PREA refresher education. There are reporting posters in Spanish and English throughout the facility. Every possible avenue has been afforded for reporting, so this standard has been exceeded.

#381 Medical and Mental Health Care:

Residents have a VAI conducted within 72 hours of Admission. All residents, including those who disclose a prior victimization and those that are identified as perpetrators, receive a physical within 72 hours of Admission. All new admissions are offered pregnancy testing and sexually transmitted disease testing as part of the Admission physical. They can also see a psychologist and/or psychiatrist through Prime Care for medication evaluations and other psychiatric needs. An Adolescent Therapist has been added to the LCYIC staff since the last Audit and she meets with every new resident within 24-48 hours of admission to do an assessment and offers them her counseling services.

Prior to the 45 day Interim report, requested documentation, including a training certificate for the Adolescent Therapist, an amendment to the PREA Policy requiring retaliation monitoring documentation and additional completed VAIs with appropriate scoring were submitted to the Auditor and reviewed. All policy and procedure is in place and all standards have been met. This facility is fully PREA compliant effective 12-3-19.

The organizational chart confirms that they have the authority within the organization to ensure compliance. The Agency, Lancaster County, has an agency wide PREA Coordinator. The PREA Managers at the Detention Center/Shelter and the County Jail report to her for PREA Matters. She is the Lancaster County Solicitor, an appointed position and she reports to the County Commissioners. During the last two Audits, the Assistant County Solicitor was the PREA Manager and participated in the Audit. She has since left that position and a new Assistant County Solicitor has just been hired and will take over the PREA Coordinator responsibilities. In the interim, the County Solicitor is the PREA Coordinator. She was interviewed on 10-21-19 at the Youth Intervention Center and states she has enough time for her PREA duties. She states that she interacts with the PREA Manager when there is an incident, to discuss response and any changes that are needed to prevent future occurrences. She also receives and reviews the Annual Report prepared by the the PREA Manager.</p> <p>The PREA Manager describes his PREA responsibilities as working with his administrative team to ensure compliance. He states that he does have enough time for his PREA related responsibilities. He is the Director of the facility and reports to the County Commissioners. This was the third Audit of this facility and the coordination, training, and implementation are in practice and part of the culture.</p> <p>The PREA Zero Tolerance Policy was provided to and reviewed during the pre-audit period. One revision was completed during the onsite portion of the Audit. The Policy describes detection, prevention, reporting and response and includes definitions of prohibited behaviors, discipline for engaging in such and implementation strategies and response to reduce and prevent sexual abuse and harassment.</p> <p>This standard has been met. There is no need for corrective action.</p>

The review of the Zero Tolerance Policy, LCYIC policies and the above documentation show compliance with staffing, supervision, and ratio. The policy takes into account all eleven of the criteria in the standard. There have been no instances of not meeting ratio and this is confirmed by interview and by review of the most recent Pa. Department of Human Services Licensing and Inspection Summaries. DHS inspects staffing during their annual licensing inspection and throughout the year if there is a reportable incident.

I reviewed documentation of yearly review of staffing by the PREA Coordinator and PREA Manager. The PREA Coordinator reviews staffing yearly or would review if there was an incident. The PREA Manager/Director states that staffing is reviewed daily to ensure one on one supervision and other resident needs are met. He personally reviews staffing because he enters staff attendance for payroll purposes on a weekly basis and now has a live video on his desk top monitor. The supervisors also write up a daily "shift report" that includes absenteeism, that the Director reviews.

The ratio that is required by the Pa. 3800 Child Care regulations is 1:6 , 1:12 for Detention and 1:8, 1:16 for Shelter and the Weekend PULSE program. The scheduled staff to child ratio always exceeds the requirements.

I was provided current staff schedules with more than the required ratio. I also requested and received random staff schedules for each program during the pre Audit time period. The Schedules are completed at least two weeks in advance and sent to staff. There are also posted in the facility and I saw them posted during the tour. The Shelter schedule is completed by the Shelter Supervisor, the Pulse Program Director completes the schedules for PULSE and the Training Coordinator completes the Detention schedule.

The use of voluntary and if needed mandatory overtime provides for any emergency staffing. Part time staff are regularly used to provide one on one supervision that may be required or

for additional staffing due to programming. There have been no deviations from the staffing ratio. The Director states that he has even filled in working midnight shifts when needed. Video surveillance is used to supplement the supervision of the residents. The cameras are manned round the clock by non-direct care staff and have an approximately 30 day recording capability. Administration now has the capability to view live video of the Units on their desktop monitors. The Director states that if a resident is on Unit confinement, he always monitors that via video from his desk.

During the tour and while on-site, I saw residents supervised on the unit for "unit confinement" as well as in the dining room and classrooms. There were two residents on Unit Confinement on 10-12-19, during the tour and two staff assigned to the Unit. On 10-22-19, I conducted some resident interviews on the Unit and there were four residents and two staff. During lunch on 10-21-19, I observed nine boys in the cafeteria, with 5 staff, not including the 3 teachers who were also eating lunch. There was only one female in Detention and she was one on one for the entire onsite, both in the classroom, dining room and living unit.

In Shelter, three residents went out to school everyday. I observed three Shelter girls with three staff in the library while on the tour. The 7 Shelter boys were in a classroom with two staff and a teacher.

In both programs, male staff work on male units and female staff work on female units.

I was provided with logs of random unannounced rounds conducted on all three shifts. I also viewed the log book while on site as well as a recording of a UAR conducted by the Shelter Director on a midnight shift. I interviewed the Shelter Director, Facility Director and Program Coordinator regarding the rounds. All three stated they conduct them, document them and never tell anyone when they are going to conduct them. The Program Coordinator states that the Facility Director assigns each Administrator a month. They must conduct a random round on all three shifts during that month and advise the Director by email when they conducted them. He records this on a log and then uploads the corresponding video recording as additional documentation of that round. He states that each Administrator ends up being assigned two months a year. During the tour I asked both staff and residents if they saw Administrators conducting these rounds and they responded that they did.

This standard has been exceeded. There is no need for corrective action.

It along with the LCYIC policy prohibits any kind of cross gender search including cross gender pat down searches. The policy also prohibits the search or physical examination of a Transgender or Intersex resident for the sole purpose of determining that resident's genital status. There have been no cross gender searches of any kind. Staff state they do not conduct them and even in an emergency they believe that a same sex staff would conduct a pat down search. Residents state that they have never been subject to a cross gender pat down search. All staff have received training regarding the search of a Transgender or Intersex resident in a respectful and dignified manner.</p> <p>Although there are discrete housing units and same sex staff work on the units, staff and residents both state that staff practice "knock and announce" when entering a housing unit that houses residents of the opposite gender. I saw posters at the door of every unit and I saw "knock and announce" practiced during the tour.</p> <p>Residents state that they shower three at a time, unless there is a restriction that prohibits that. Same sex staff conduct showers. Shower procedure, including placement of staff was demonstrated for me during the tour. I saw the designation "shower alone" for a resident in on a housing sheet. Transgender or Intersex residents would shower alone according to policy and interviews. All residents can shower, toilet, change clothes and perform bodily functions without being viewed by staff of the opposite sex according to interviews of both staff and residents.</p> <p>There are no cameras in the resident rooms or in the bathrooms, where they have an expectation of privacy.</p> <p>This standard has been met. Staff stated that the use of a resident as a translator for reporting sexual abuse or sexual harassment is prohibited by policy and does not occur. The two residents with Intellectual impairments were in the Shelter Program. The one girl stated she had Learning Support in her home school but did not require any accommodations for PREA education. The other resident had a diagnosis of Autism . She too stated that she did not require any special accommodations. Both girls had IEPs (Individual Education Plans). Staff take a post test, which was provided to me, and must score an 80% in order to receive a certificate. I reviewed 8 random staff files to ensure yearly training that is appropriate. This file had acknowledgement of PREA training.</p> <p>The volunteer, who conducts creative writing, journaling, with both Detention and Shelter residents on a weekly basis, described the PREA literature he reviewed and signed off on and also the in person training for a group of volunteers that included a presentation and a question and answer section. His file also contained a signed acknowledgement of his training. The other volunteer file that I reviewed also contained signed acknowledgement of PREA training.</p> <p>The eight volunteers and contractors who were interviewed were able to tell me that they would report to an on-duty supervisor and/or the Director as well as Pa. One answered yes, and the other stated she had just started working there three weeks before and had not. This signed orientation checklist is placed in the resident's file. Additionally on the first of each month on second shift, staff conduct PREA refresher education for all the residents. The residents take a test which demonstrates attendance and comprehension. I was provided with logs of this monthly education.</p> <p>I saw the logs of both Intake and ten day education. I reviewed the files of 13 residents, 11 active and 2 discharges from Shelter and Detention and all had the Intake and ten day education acknowledgement in their files. One girl in Shelter has 15 monthly PREA tests in her file because she had been at the facility for 15 months.</p> <p>I interviewed ten random residents from Shelter and Detention and all stated they received education when they first got here and that this education advised them they had a right to be free from sexual abuse and harassment, how to report, and that they could not be punished</p>

for reporting sexual abuse and harassment. One resident in Shelter stated she had received education several times, because of her length of stay and could recite the monthly PREA test answers by memory, which she proceeded to do. While Auditing another Agency within the past two months, a resident at another facility told me he knew all about PREA because he had been a resident at LCYIC and had taken the monthly tests.

There are MP3 players for residents who need audio education due to a disability. Spanish and English posters and brochures are available as is a translation service. I interviewed two residents with Intellectual Impairments. They both stated that they did not require any special accommodations for PREA education and in fact candidly discussed their PREA education. The one girl had a diagnosis of Autism and the other girl stated she had a learning disability. Both have Individual Education Plans (IEPs) that follow them from their home school to the educational program at the Youth Center.

Due to the individualized ten day education and documentation as well as the formalized continuing education and documentation, I feel this standard has been exceeded.

These are conducted at the Lancaster General Hospital and there is an MOU with the Hospital. I interviewed two full time Nurses and I also interviewed the Adolescent Therapist. Both Nurses have completed the Prime Care PREA Training and have also completed the training for all staff at the LCYIC. Both state that they do not conduct forensic examinations and that they both have received training regarding the sexual abuse of juvenile victims. They both received training on the protection of forensic evidence. Both are mandated reporters and would report to their Prime Care Supervisor, the on-duty supervisor at LCYIC and to Child Line. They would both document any reports they received. I received certificates of completion for the NIC PREA online course for all Prime Care contracted employees and I received certificates of completion for the full time nurses that they had received the same education as the Youth Center employees. All Medical and Mental Health staff are mandated reporters and receive Mandated reporter training every 2 years as required for their professional licenses. The Adolescent Therapist received the all employee training and specialized training when she was an Caseworker for the Office of Children and Youth. She had not received the specialized PREA training that covers the information in the standard. Prior to the 45 day Interim report, the MH employee completed the NIC online specialized training for Medical and Mental Health employees. A certificate of completion was provided to me. This standard has been met. There is no need for corrective action</p>

The VAI form requires documentation for risk based housing consideration that includes: shower alone, assignment to rooms 3-7, one on one supervision or constant watch. This must be completed for anyone scoring Vulnerable to Sexual Victimization and/or Sexually Aggressive. Additionally if a child discloses a prior victimization or is a perpetrator, the staff conducting the VAI must record the offer of Medical and Mental Health follow up and the acceptance or declination on the form itself.</p> <p>The staff who administer the instrument: the caseworker for Detention and Shelter residents and the PULSE program supervisor for PULSE admissions take into account the Health and Safety Assessment that is conducted at Intake, the Intake interview, conversations with parents, probation officers and caseworkers, court reports and any other information that may accompany the child. They both use the VAI as a guideline and use a combination of developing a conversational rapport with the resident and asking direct questions. The PULSE Director states that she completes the VAI at the 40 hour mark , on the first Sunday so that the kids have an opportunity to get to know the staff.</p> <p>The CW for Detention and Shelter conducts PREA education for the residents and uses the education as a way to elicit information.</p> <p>All completed VAIs are kept separately by the staff completing them and the only persons with access are the medical and administrative staff. All pertinent necessary information is recorded in a housing log and emailed/faxed to medical staff. A discharged resident's VAI will go into their file that is kept in a locked area in the administrative offices.</p> <p>I reviewed the files of 13 residents (11 active and 2 discharges). The discharged files were chosen randomly from those admitted during the past 12 months. All had timely administration of the VAI. Two of the files had the VAI administered again at the 6 month mark. One Shelter girl had three VAIs in her file conducted at Intake, 6 months and 12 months.</p>

I interviewed 10 residents from both Shelter and Detention and all could state that they were asked questions when they first arrived as to whether they had ever been sexually abused, if they had any disabilities or if they were fearful of sexual abuse at LCYIC.

Although all information was documented and available, I learned during the interview with the Caseworker that she was not using the information from other sources to score the VAI, unless it was reported to her by the child. She did incorporate the information into housing consideration and showering alone and I saw documentation of this on the VAIs.

During the onsite, the Shelter program had an Intake and the CW conducted the VAI using information from the Health and Safety Assessment to correctly score the VAI. This was provided to me. As part of the plan of correction, the CW will scan and send the completed VAIs of all admissions from the time of the onsite until the 45 day Interim report to ensure that scoring is being done properly and the information that is gathered is reflected in the score. The PULSE Director was scoring the objective instrument as required.

On 12-2-19, all VAIs conducted on the 17 new admissions from 10-22-19 through and including 12-2-19 was submitted to the Auditor. The VAIs showed that the Caseworker was utilizing all information to arrive at a valid score on the instrument. Five of the seventeen admissions had notes regarding information, where it came from and attempts to verify. This documentation is evidence that the instrument is being scored properly to ensure the sexual safety of all residents.

The documentation submitted satisfies the plan of correction.

This standard has been met. There is no need for further corrective action.

Department of Human Services 3800 Child Care Regulations. I interviewed the above staff who state that any resident who is identified as either vulnerable or aggressive on the risk screening is considered for housing on a unit or in a room that would protect either that resident or the other residents. While on the tour, I saw units with younger residents and also rooms that are closer to the staff office and are within both eye and ear shot of staff. Both the units and the rooms are used for risk based housing. Residents go to school, programs and eat according to housing unit. I also saw the bathrooms that have three shower stalls with curtains. LCYIC policy calls for residents to shower three at a time, but also allows for residents to shower alone for several reasons, including an identification of Transgender or Intersex. The housing log uses abbreviations such as SA for shower alone. The staff state that there are no specific or segregated housing units for LGBTI residents. Transgender or Intersex resident housing would be determined on a case by case basis and would be formally reviewed every thirty days and most probably weekly. The residents own views for their safety would be taken into account when making housing decisions as well as the safety and security of all the residents. A LGBTI resident is never identified as sexually aggressive based solely on their LGBTI status.</p> <p>I interviewed two residents who identified as bi-sexual. A third resident who identified as bi-sexual refused to be interviewed. The female resident from Detention, who identified as Bisexual states that she showers alone, which she prefers, and is not discriminated against in any way. I interviewed a resident from Shelter, a girl who identified as bi-sexual, and she stated she was not discriminated against in any way.</p> <p>I reviewed the housing logs and all three residents were placed in regular rooms on the sex appropriate unit.</p> <p>I reviewed the files of 13 residents (11 active and 2 discharges). All risk based housing recommendations are recorded on the instrument itself and communicated to the supervisor on duty who makes the room assignments and documents them on the housing log for Detention and Shelter residents. The PULSE Program supervisor makes the decision for those</p>

residents.

Of the 11 active resident files that I reviewed one of the Shelter residents was identified as Sexually Vulnerable and I saw a Shower Alone designation on his VAI and his housing sheet. All rooms are single rooms and in Detention, all residents are secured in their rooms at night. The policy contains all necessary verbiage and according to the interviews and the reviews of the housing logs is practiced.

It mandates that staff accept resident reports in all these formats and that they document and report to Pa. Child Line and their supervisors immediately. All residents and staff interviewed were able to tell me at least two ways a report could be made and most were able to tell me many ways a report could be made including the PREA Dropbox, telling staff, grievance procedure, and sick call slip.</p> <p>The primary reporting mechanism is to an outside agency the Lancaster County YWCA, a member of the Pennsylvania Coalition Against Rape. There is an MOU with this agency and this "hotline" allows for receipt of the report and transmission to the facility anonymously if requested. Prior to the onsite I did a telephone interview with the Director of the YWCA and she confirmed the services outlined in the MOU. This reporting method is posted throughout the center. The private "hotline" is located in the hearing room near the administrative area, but is also accessible through all phones on all units. The number is posted above the phones in both Spanish and English. I tried the phone on the Detention Unit, while on the facility tour, and spoke to a staff person from the YWCA.</p> <p>It worked as described. The residents call this "hotline" the "gray Phone". The phone system has changed since the last Audit and although the phone is no longer gray, both staff and residents call it the gray phone when referring to the hotline.</p> <p>The residents can also call Child Line and the staff as mandated reporters must do so. The Pa. Department of Human Services 3800 Child Care Regulations requires a Grievance Policy and that all residents and their parents receive it and acknowledge it. This is another avenue for reporting and is contained in every child's file and is audited by PA. DHS during their</p>

annual licensing inspection.

Residents can also call home at least once a week and some residents can call home two times based on levels according to resident interviews. Residents can receive visits from parents and grandparents twice a week. If a resident has a child, special accommodations can be made for that child to visit. There were posters in the Units regarding Resident parent/child visitation.

Visits by Probation Officers, Caseworkers, Guardian ad Litem and Attorneys are not limited and residents confirm they receive them. The Director stated that on Mondays each child is given an opportunity to request a visit/phone call from lawyers, POs, CWs, etc. This is then emailed by the LCYIC staff to the appropriate parties. It is up to that individual to call or visit. While interviewing a Detention resident he stated that he wanted to contact his Public Defender and had not been able to do so. I relayed this request to the Detention Supervisor, who later advised me that he emailed that lawyer as required by LCYIC policy.

The PREA boxes are located in several areas of the facility in both Shelter and Detention and are checked by the Caseworker on a daily basis. There are tools, such as pencils and paper throughout the living units and in the classrooms for the residents to write letters, grievances or to report as observed during the tour.

During the tour, both a Detention resident and a Shelter resident were able to volunteer and spontaneously tell me about how to report.

All staff and residents were able to provide me with at least two avenues to report.

This standard has been exceeded and there is no need for corrective action

If they do, they can do so without having to submit or refer to the staff involved in the grievance. The timeline for the resolution of the grievance is 7 days according to the policy and within 48 hours if it is an emergency grievance. Residents cannot be disciplined for filing a grievance.</p> <p>The Pa. Department of Human Services 3800 regulations require a grievance policy and notification and acknowledgement of such by both the resident and their parent/guardian. Pa. The Resident handbooks and the education that they receive at different intervals throughout their stay also includes what services are offered and how to contact this agency to access these services.</p> <p>The Facility Director described the MOU with the Lancaster YWCA, a member of the Pa. Coalition Against Rape (PCAR) and the services that they offer. The MOU was reviewed and I spoke to the Director of the Victim Advocacy Program at the YWCA on 9-26-19 by telephone prior to the Audit to confirm the services offered in the MOU.</p> <p>The residents who were interviewed in both Shelter and Detention state that they can make and receive phone calls. Other Shelter resident attend school in the community and are picked up and returned by the School District each day. Probation officers, caseworkers, and attorneys are not subject to the visiting or telephone policy and can visit when it is convenient. The residents that were interviewed state that they usually see the Public Defender before Court. One Detention resident stated that he had a private attorney who he spoke to and has seen several times. Another Detention resident stated he had not seen his attorney and wished to. This information was passed on to the Detention Supervisor.</p>

The Director states that each Monday the facility distributes a "call list" and the resident signs up if they want to speak to their PO, PD, OCY worke,r etc and the facility emails this list to that County Department.

All 10 residents who were interviewed were able to tell me that there are outside services offered for sexual abuse but two of the ten residents were unable to tell me about the services offered through the YWCA. I directed them to the poster in the visiting room we were in and they were able to discuss this. This information is also provided to them at Intake and at other times during their stay. I saw in their files that they had initialed that they had received this information.

Two attend school outside of the facility and were not present during the Audit. A third resident, a Shelter girl, refused to be interviewed. A review of the 13 resident files, showed that of those that did not accept services there was a signed declination and the other were seen within 14 days.

The Nurse states that she coordinates both the Medical and Mental Health follow up through Prime Care. The Adolescent Therapist, who is a YC employee, states that she meets with every new Shelter and Detention Admission within 24-48 hours of admission and offers them her services. If they agree, she does a formal assessment. She provided logs of her meetings with admissions within this time period.

The practice of all residents being offered services with an adolescent therapist, and receiving a physical exceeds the standard. Interviews and documentation support this finding.
